## Simultaneous Instructional Models



Clayton County Public Schools will ensure the continuity of high quality teaching and learning for students who are learning face-to-face and remotely.

A primary focus will be to ensure optimal opportunities for learning to accelerate students to grade level performance and beyond.

### Instructional Delivery Model:

Schools will use a combination of instructional models to ensure high-quality teaching and learning.

- Synchronous (live with the teacher)
- Asynchronous (independent student-learning)
- Unplugged (minimal to no use of technology)

### Simultaneous Teaching

- Once students return to facilities for learning, schools will implement Simultaneous Teaching in order to instruct remote learners and face-to-face learners. This model will require teachers to use technology resources and a combination of synchronous and asynchronous instruction.
- To support the implementation of Simultaneous Teaching, instructional staff will receive professional learning in the following:
  - Rituals and Routines
  - Lesson Design and Delivery
  - Effective Use of Digital Resources
- Face-to-Face and At-Home Remote Learners will operate on the same daily instructional schedule.

\*\*The trainings will be held from 9:00-11:00 a.m. on March 25th and 26th

Administrators will administer a survey to parents to determine if their children will return to face-to-face instruction or learn remotely.

### Elementary School Schedule:

#### Hybrid Instructional Model (A Day/B Day)

Students in grades PreK-5 will participate in this model during weeks 1 and 2, April 12-22, 2021

Blended/Simultaneous learning provides students with an opportunity to engage in technology-supported learning and in-person learning due to purposeful alignment between the two delivery models (Kieschnick, 2017). More specifically, students in Clayton County Public Schools who participate in an *A-Day/B-Day Instructional Schedule Rotation* will alternate between both face-to-face instruction and at-home virtual learning (remote learning).

## Elementary School Schedule:

### Face-to-Face Instruction

Students will participate in this model beginning week 3, April 26 - May 25, 2021, for students in Grades Pre-K-5th

If students return using the traditional face-to-face model, then they will return Monday through Friday adhering to the start and end times. Fridays will no longer be an Extending Learning Beyond the Classroom day.

Beginning on April 12, 2021, Clayton County Public Schools will offer a full-time, at-home, remote learning option for families who have elected to continue learning virtually for the remainder of the 2020-2021 school year.

### Virtual Learning (Full-time at-home remote learning)

### All Middle and High School Self-Contained and Low-Incidence Students who have selected to remain virtual:

Students will still receive instruction from certified teachers. Students may be expected to engage in a combination of synchronous (live and virtual) and asynchronous (independent) learning activities. Beginning the week of April 26th, virtual learning students are expected to participate in instruction Monday through Friday.

### Student Schedules

- If a student is an A-Day student, the student will be scheduled Monday and Wednesday. B-Day students will be scheduled for Tuesday and Thursday in Infinite Campus (IC).
- All students will be assigned an A/B Day schedule based on their home address..
- Parents will receive an email via IC informing them of their child’s A/B Day schedule. The student’s schedule will also be available in the Parent Portal in IC

### School Supplies

Students participating in the A-Day/B-Day Instructional Schedule Rotation will need to bring the following items to school on their scheduled in-person instructional day:


- Mask
- Earbuds
- A fully charged Chromebook in the Case
- Paper and Pencil
- Students will be allowed to carry their book bags during the school day. Lockers will not be distributed for the 20-21 School Year.  
**\*\*Students in grades K-2 will not need to transport their laptop to school each day. They will be provided with technology when they arrive at school.**

### Dress Code and Grooming for Students:

All students are expected to dress appropriately for school. Students and their parents/guardians have the primary responsibility for adherence to the Clayton County Public Schools policies and procedures. Teachers and all other school personnel will reinforce acceptable student dress and help students develop an understanding of appropriate appearance. The students in grades Pre-K - 12 are not required to wear a school assigned uniform for the remainder of the 2020-2021 School Year. However, students must dress appropriately and adhere to the policy described below. Students will have an option to wear a school uniform if so desired.

- Belts are required, no sagging of pants
- Flip-flops, shower shoes, skate shoes, and house slippers are not permitted
- Headgear of any kind is not allowed. (Exceptions are considered for headwear or scarves worn as a part of a student’s religious practice or documented medical reasons)
- Skinny pants, tights, or leggings that substitute as pants are not acceptable

These classrooms will have additional signage, PPE for staff, and handwashing requirements prior to entry to the classrooms. Students with medical needs requesting to remain in virtual learning based on medical concerns who require direct IEP services and who are not on VLA or may need additional services will be requested to apply for hospital/homebound services.</li> </ul> <p><b>Visitors to Special Education (DES) Classrooms:</b></p> <ul style="list-style-type: none"> <li>• Visitors to the school for parents/staff will follow the district’s visitor guidelines with strict restrictions. Visitors completing outside evaluations and/or observations for evaluation purposes will be scheduled with DES District Leadership. This visitation will be completed virtually as technology is available and set up so that these requirements can still be met without bringing more people into the building.</li> </ul>

## Daily Routines

### Morning Arrival

All teachers will be at their door ready to supervise and receive students. Additional staff members will be on duty throughout the building during arrival and dismissal times. Signage will be posted to direct students on movement procedures.

#### 7:00 Morning Bus (Nursery, Daycare Vans) Arrival

- Students will remain seated on the bus until instructed to unload. Students will unload one bus at a time and will enter through the main entrance doors. Temperature will be checked upon entrance.
- Supervision by staff will ensure responsible distancing as students proceed to classrooms.
- Church Street's current "walk on the right side of the hall" policy will be followed both coming and going from any destination.
- Non-Homeroom teachers and staff on duty will be at their assigned area no later than 7:00 am.

#### 7:00 - 7:40 Car Riders Arrival

- Car riders will be able to unload from 7:00 AM to 7:40 AM daily.
- Movement will be managed by staff using the school protocol.
- Only students will be allowed into the school building. No one dropping off students should exit their vehicle during morning arrival.
- Staff will be on duty outside to support students and parents.
- Restroom times will be scheduled and staggered during arrival and dismissal.

### Breakfast (7:00 - 7:50 am)

- Staff will assist with monitoring, supervising and social distancing of students as they receive their meal. Students will eat in their classrooms and/or cafeteria.

## Lunch

- Each grade level will have lunch in the cafeteria, classroom and/or a designated area.
- Cafeteria monitors will assist with supervision of students, sanitizing areas and monitoring social distancing.
- An administrator will be on duty to assist with monitoring and supervision. Our lunch window is 10:00-1:00 pm.
- A staggered lunch schedule will be created to allow for ample space between students entering the cafeteria.
- Students are not permitted to share food.
- Students will file in and then exit flowing in the same direction.

There will be no visitors eating with students during lunch. No treats or outside food for birthdays and/or special events will be shared with your child's class.

## Transitions within the Building

When moving to and from locations within the school, students will walk following normal traffic flow patterns. The number of students in the hall at any given time will be minimized by scheduling and procedures that are in place to ensure students are responsibly distanced. Students will be supervised in the hall and common areas.

Lunches, special transitions, and restroom breaks will be staggered in order for social distancing to occur.

### TRAFFIC FLOW Plan:

- Students will walk on the right side of the hallway (third square).
- Red circles, to ensure responsible distancing, have been placed on the floor throughout the building. These markings will be a visual reminder of the distance between the person in front and behind students when in line and transitioning in the hallways.
- During transitions, students will pause at the red circle when stopping intermittently as they move from place to place in the building.

## Specials/Connections/Electives

- Music, Art, and PE teachers may push-in to K-2 student classrooms. Students in 3-5 will transition to specials.

## Dismissal

### Campus Kids (CKIDS), and Nursery/Day Care:

- When released, CKIDS, and Day Care/Nursery riders will move to their designated area. Students will walk on the right side of the hallway.
- Teachers will supervise students when they are released to ensure responsible social distancing.
- Face coverings will be required.

### 2:00 Car Dismissal:

- After reporting to designated area, a staff member will call students once their vehicle arrives.
- Students will proceed to the car rider lane. No one picking up a student should exit their vehicle during dismissal.
- Additional staff members will be assigned to locations throughout the building to monitor responsible distancing & student safety.
- Face coverings will be required.

### 2:05 Bus Dismissal:

- When released, bus riders will report to the bus lane. During dismissal, traffic will flow on the right side of the hallway.
- Supervision by staff will ensure responsible distancing as students proceed to exit to the bus lane.
- Face coverings will be required.

## School Nutrition



## Students that attend school during any of the approved models will be provided breakfast, lunch, and a snack during the school day

- Meals will continue to be delivered on bus routes in the community on Mondays, Wednesdays, and Fridays (Monday - Saturday meals) until the end of the school year from 9:30 a.m. through 11:30 a.m.
- Curbside meal pickup will continue to be offered Monday – Friday from 9:00 a.m. through 12:00 p.m. at most locations (some sites have been shut down due to low participation).
- Breakfast meal service can begin as early as 7:00 a.m. and continues through 7:55 a.m.
- Upon arriving at school, students are to report to their assigned classroom prior to the start of breakfast.
- Lunch and snack meal service can begin as early as 10:00 a.m. through 12:00 p.m.
- Principals reserve the right to choose whether meals will be consumed in the cafeteria or classroom.

## Campus Kids



- All elementary schools will offer after school care for the remainder of the school year
- There will be an electronic check-out process and Online Registration process - No visitors will be allowed in the building
- Registration fees have been waived for SY20-21
- Tuition Rates:
  - A-Day/B-Day = \$20 (2 days/\$10 per day)
  - Full Week = \$40 (5 days)
- There will be a 20:1 Student to Teacher Ratio
- PPE will be provided to all students and staff, and there will be a cleaning routine that will be followed in all facilities
- A healthcare technician or a COVID-19 Response team member will operate the isolation room during Campus Kids

## Safety Protocols for Facilities



### Safety Measures in the Classroom

- Students should have assigned seats in the classroom and all other locations for efficient contact tracing. Teachers should maintain physical copies of seating charts.
- Seating should have students facing the front of the classroom and/or not seated directly behind another student if possible.
- Staff and students should have their own assigned resources, equipment, and supplies - as feasible.
- Resources, equipment, and supplies must be disinfected in between uses if they are being shared.
- Staff and students should frequently wash and/or sanitize their hands.
- Frequently-touched surfaces must be disinfected regularly.
- The virtual learning platform should be leveraged as much as possible to minimize physical interaction, especially during group work.
- Teachers should use plexiglass or physical distancing during small group instruction.
- Staff and students must wear face masks when they are not eating or drinking.
- It may be necessary to leave classroom doors open for ventilation purposes.

### Ensure that high touch surfaces are cleaned every hour throughout the school day


- High touch surfaces include: tables, doorknobs, light switches, countertops, handles, desks, phones, keyboards, toilets, faucets, sinks, chairs, phones, tables, etc.
- Food-contact surfaces must be washed, rinsed, and sanitized after each use
- Surfaces and objects in public places, such as keypads should be cleaned and disinfected before each use (i.e. teacher sign-in keypad, student breakfast/lunch keypad, etc.)
- Schools\Custodians are being provided reusable microfiber towels to enhance their current cleaning system

### The following PPE will be provided and the Safety Protocols will be implemented:

- Desk Shields
- Face masks for all students
- All classrooms have been equipped with a spray bottle of sanitizing solution to be used to clean desks, tables, computers, etc. in the classroom
- Hand sanitizer stations
- Temperature checks upon entry to the building
- Frequent hand-washing will be encouraged
- Social distancing encouraged

<p><b>Transportation</b></p> 	<p><b>Guidelines and Expectations:</b></p> <ul style="list-style-type: none"> <li>• Transportation will use the pre-existing routes to transport students</li> <li>• Students will be transported to and from school</li> <li>• If a student boards a bus on the wrong day during the A Day/B Day Hybrid Model, the driver will transport the student(s) to school and place them in the care of school administrators to contact parent(s) in order to secure transportation home.</li> <li>• Students' temperatures will not be checked at bus stops, but will be checked when the student enters the building.</li> <li>• Elementary routes and Nutrition routes will be posted on the Transportation website for parents to review. Parents can utilize WebQuery to identify stop locations - click <a href="#">here</a>.</li> <li>• There will be a maximum of 40 students per bus load</li> <li>• Students will be required to wear masks on the bus while being transported</li> <li>• Transportation will deliver meals to the community beginning at 9:30 a.m. daily on Monday, Wednesday, and Fridays for students who are enrolled in virtual learning.</li> <li>• Transportation will make adjustments to ridership counts within 30 days of school reopening to ensure routes are safe and efficient</li> <li>• Transportation staff will be equipped with PPE equipment</li> <li>• Drivers and Transportation shop staff will spray the interior of each bus with sanitizing chemicals daily between routes. This will take approximately 10 minutes between each route.</li> </ul> <p><b>Procedures for transporting special needs students</b></p> <ul style="list-style-type: none"> <li>• Staff will create and/or modify routes based on transportation requests</li> <li>• Students in Self-Contained classes (Autism, Intellectual Disabilities) will begin on an A/B Rotation and increase to a full 5-day (Monday-Friday) option if attending face-to-face after two weeks of orientation. ## Health Protocols



All Students and Staff will wear masks at all times.  
All Students and Staff will have their temperatures taken upon entry to the building.  
Frequent handwashing will be encouraged and hand sanitizer will be available.

**If staff or students become ill, they will be quarantined in a designated area (the isolation room) and students will remain isolated until they are picked up by a parent/guardian.**

- The school nurse and/or other health care technicians will render the necessary medical attention or first aid based on the symptoms being exhibited.
- The parent or guardian will be immediately notified and advised to expeditiously respond to the school to retrieve the student for further medical treatment.
- Staff members and students with confirmed COVID-19 should not return until they have met the state Department of Public Health (DPH) criteria to return to work.
- Those who have had close contact with a person diagnosed with COVID-19 should remain home and follow state DPH guidance if symptoms develop. If a person does not have symptoms, follow appropriate state DPH guidance for home quarantine. The healthcare technician will assist with next steps.
